

# Parking Services

Fees and Charges (2016/17)



## 1. Introduction

This document sets out Parking Services current charges for the financial year 2016/17 and includes fees and charges applicable to parking on the highway or to suspend the use of parking spaces on the highway.

## 2. Residents permits

Charges applicable to residents in respect of vehicles left in parking places where the adjacent sign includes the words "Resident permit holders" and "Permit holders" together with a permit identification code beginning "CA" followed by an alphabetic character or characters.

### Basic charges applying to conventionally powered vehicles:

Tariff 1 applies to vehicles with CO2 emissions rated up to 150g/km or, in the case of vehicles first registered prior to 1 March 2001, with an engine capacity between 0 and 1,299cc.

Tariff 2 applies to vehicles with CO2 emissions rated between 151 and 185g/km or, in the case of vehicles first registered prior to 1 March 2001, with an engine capacity between 1,300 and 1,849cc.

Tariff 3 applies to vehicles with CO2 emissions rated between 186 and 225g/km or, in the case of vehicles first registered prior to 1 March 2001, with an engine capacity between 1,850 and 2,449cc.

Tariff 4 applies to vehicles with CO2 emissions rated over 225g/km or, in the case of vehicles first registered prior to 1 March 2001, with an engine capacity of 2,450cc or over.

A charge is also made for each diesel powered vehicle registered to the permit which is payable again on renewal of the permit. The diesel surcharge for the financial year 2015/16 was £10.61 per diesel powered vehicle. There is a £10 discount applied to the tariff where applying for or renewing online.

### Basic charges applying to electrically powered vehicles:

### Other charges applicable to resident permits:

Residents may register up to three vehicles to each permit. A charge is payable in respect of the second and third vehicles at the time of registration and on renewal of the permit. The basic charge is determined according to the tariff which is applicable to the vehicle with the highest rated emissions or engine size whether or not any other vehicle registered to the permit is electrically powered. A charge is also made for each diesel powered vehicle registered to the permit which is payable again on renewal of the permit.

### 3. Visitors permits and e-visitor permits

Charges applicable to residents in respect of visitors' vehicles left in parking places where the adjacent sign includes the words "Resident permit holders" or "Permit holders" together with a permit identification code beginning "CA" followed by an alphabetic character or characters.

### 4. Business permits

All permits listed under this section have a validity period of 12 months.

**Business Scheme 'A'** – charges applicable to businesses in respect of vehicles left in parking places signed "Business permit holders only" followed by an numeric identification code prefixed with the letter "A". A charge is also made for each diesel powered vehicle registered to the permit which is payable again on renewal of the permit.

## 5. Market traders permits

Charge applicable to market traders in respect of vehicles left in parking places in the vicinity of the market operating in the street indicated where the adjacent sign includes the words "Permit holders" together with the identification code "MKT" or a numeric code prefixed with the letter "T". A charge is also made for each diesel powered vehicle registered to the permit which is payable again on renewal of the permit.

## 6. Other permits

**Car Clubs:** charge applicable to car clubs in respect of vehicles left in parking places signed "Car Club permit holders only" together with a numeric permit identification code prefixed with the letters "CC".

**Doctors:** charge applicable to doctors and medical practices in respect of vehicles left in parking places signed “Doctor permit holders only” together with an numeric identification code prefixed with the letter “D”. A charge is also made for each diesel powered vehicle registered to the permit which is payable again on renewal of the permit.

## 7. Limited stay paid-for parking places

Charges applicable in respect of vehicles left in parking places where the adjacent sign indicates that payment is required either by phone or at a payment machine.

Tariff 1 applies in all parking places located in the area bounded by Finchley Road, West End Lane, Mill Lane, Sumatra Road, West End Lane, Quex Road and the borough boundary with the London Boroughs of Brent and Barnet excluding any parking places in the aforementioned streets where tariff 2 applies.

Tariff 3 applies in all parking places located in the area bounded by Finchley Road, Adelaide Road, Chalk Farm Road, Hawley Street, Hawley Road, Kentish Town Road, St. Pancras Way, the North London Line, the borough boundary with the London Borough of Islington, the A501 and the borough boundary with the City of Westminster. This tariff also applies in parking places located in Hampstead High Street, Heath Street, Rosslyn Hill north-west of the junction with Pond Street, Downshire Hill, South End Road, Willoughby Road, Gayton Road, Church Row, Holly Bush Vale, Fitzjohn’s Avenue north of the junction with Lyndhurst Road, Prince Arthur Road, Greenhill and Perrin’s Lane.

Tariff 4 applies in all parking places located in the area bounded by the A501, Gower Street, Bedford Square (north-eastern arm), Bloomsbury Street, Great Russell Street, Bloomsbury Place, Southampton Row, High Holborn and the borough boundary with the City of London and the London Borough of Islington, excluding any parking places located in the aforementioned streets.

Tariff 5 applies in all parking places located in the area bounded by the A501, Gower Street, Bedford Square (north-eastern arm), Bloomsbury Street, Great Russell Street, Bloomsbury Place, Southampton Row, High Holborn and the borough boundary with the City of London and the City of Westminster including any parking places located in the aforementioned streets.

Tariff 6 applies in the parking places designated for buses in Albany Street, Montague Place and Bedford Row.

Tariff 2 applies in all other parking places not identified above.

## 8. Parking Permissions

Charges applicable in respect of vehicles left on yellow lines (dispensation to wait) or in parking places where the adjacent sign includes the words “Resident permit holders” or “Permit holders” together with a permit identification code beginning “CA” followed by an alphabetic character or characters.

## 9. Parking suspensions

The charge to suspend the use of a parking space comprises an administration fee plus a charge based on the amount of space and duration of time over which the parking space(s) will be suspended. A "parking space" is considered to be 5 metres. A charge for skip licences will be added if this is the purpose of the request. A short notice fee applies in certain circumstances.
