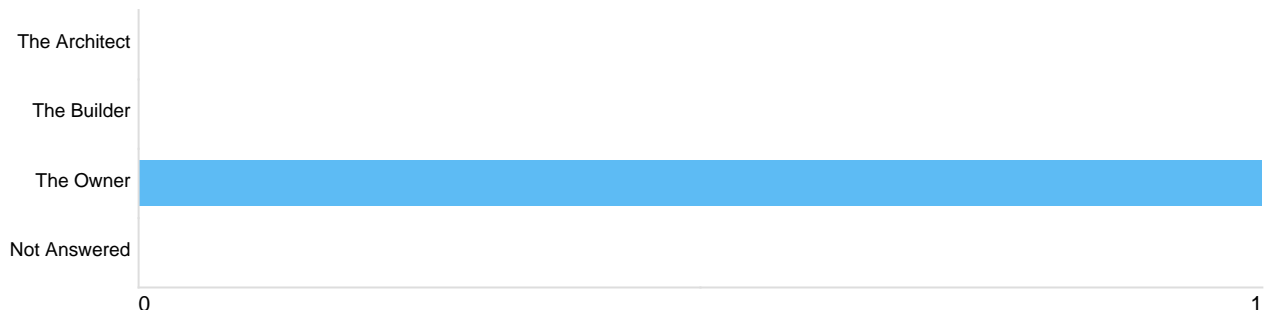

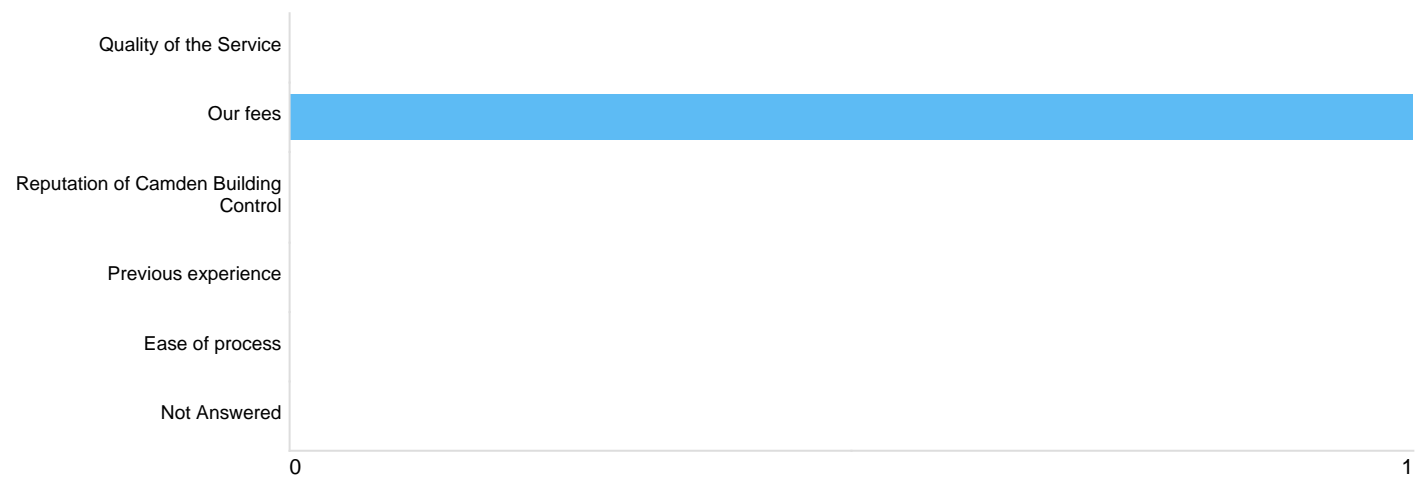

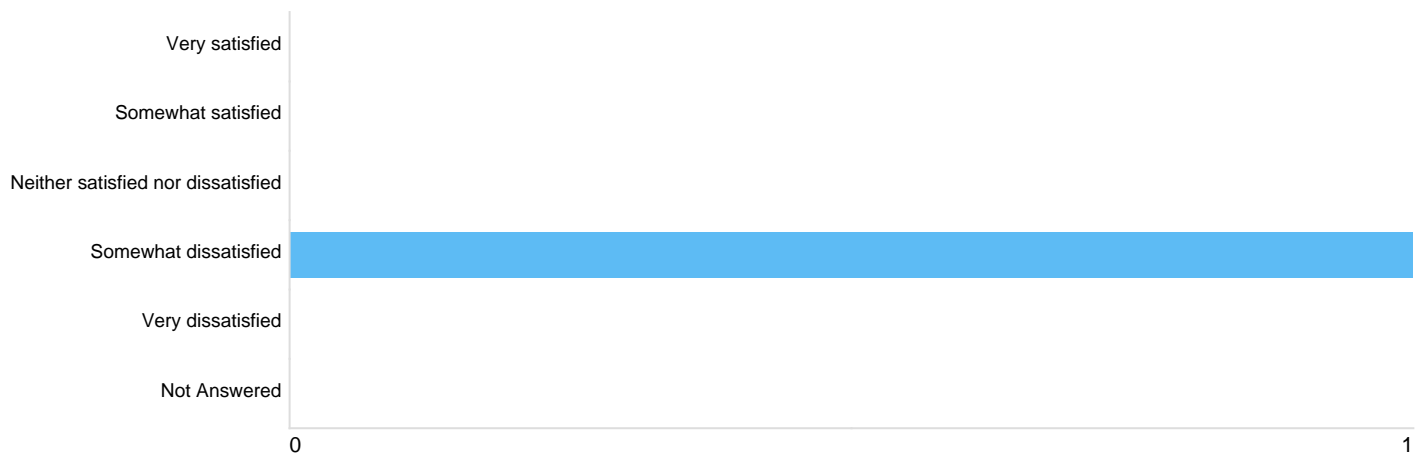

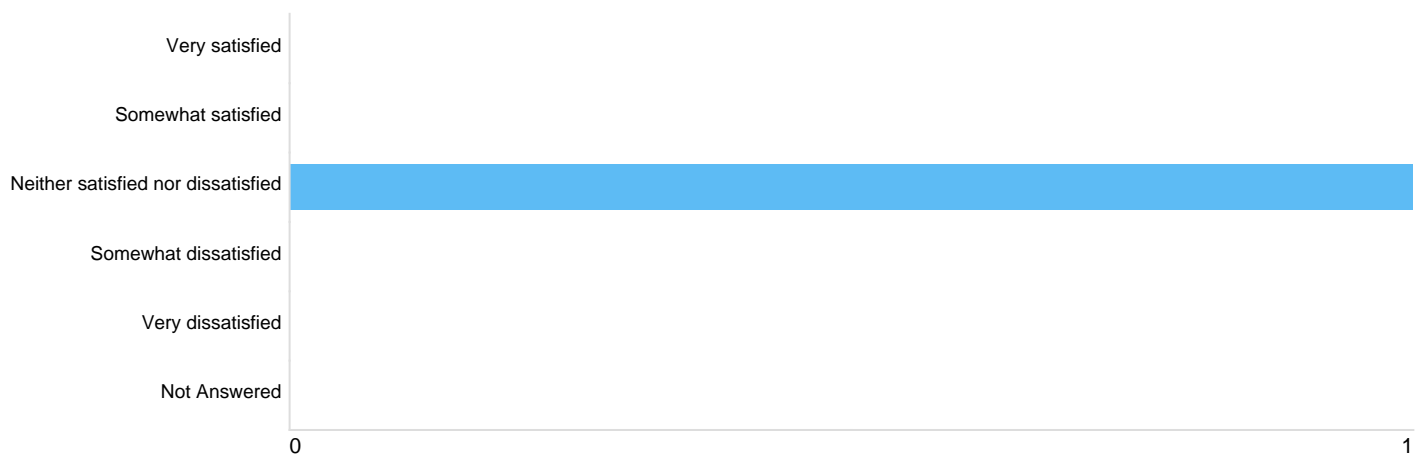

Matrix 1 - Process of submitting an application



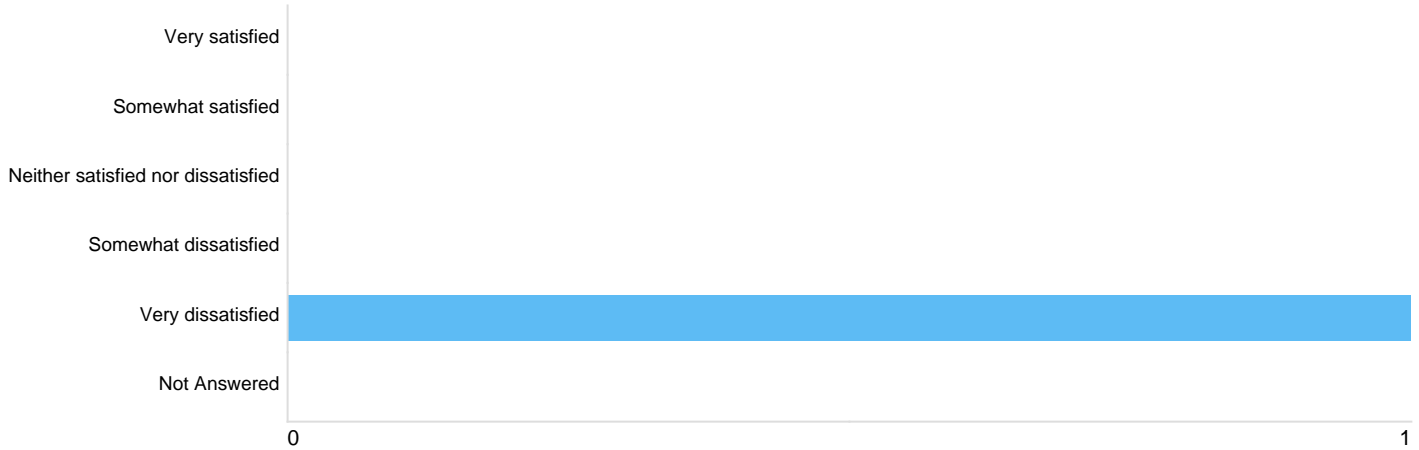

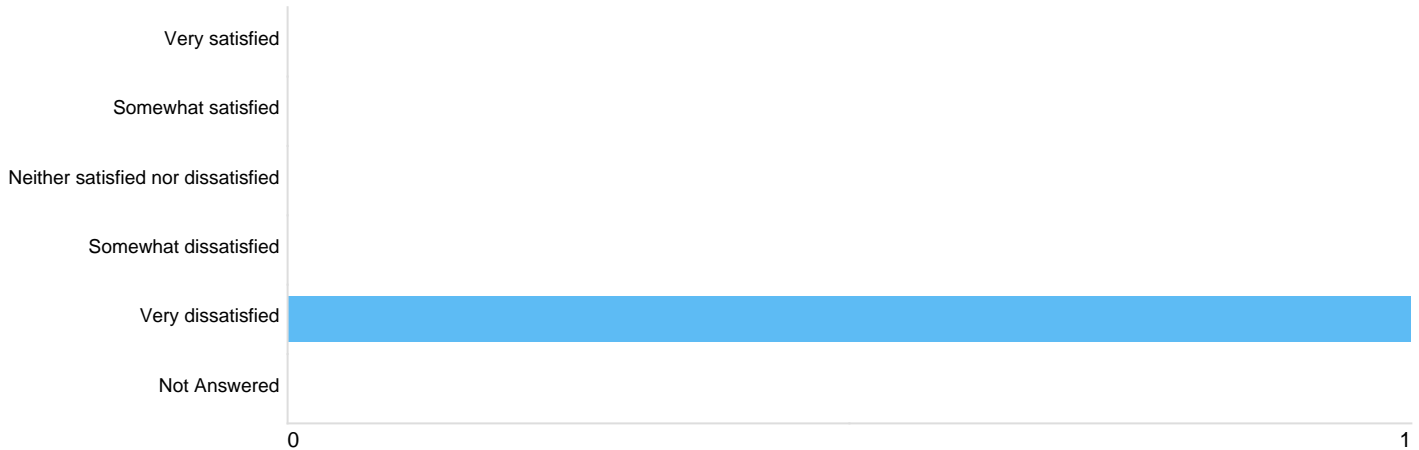

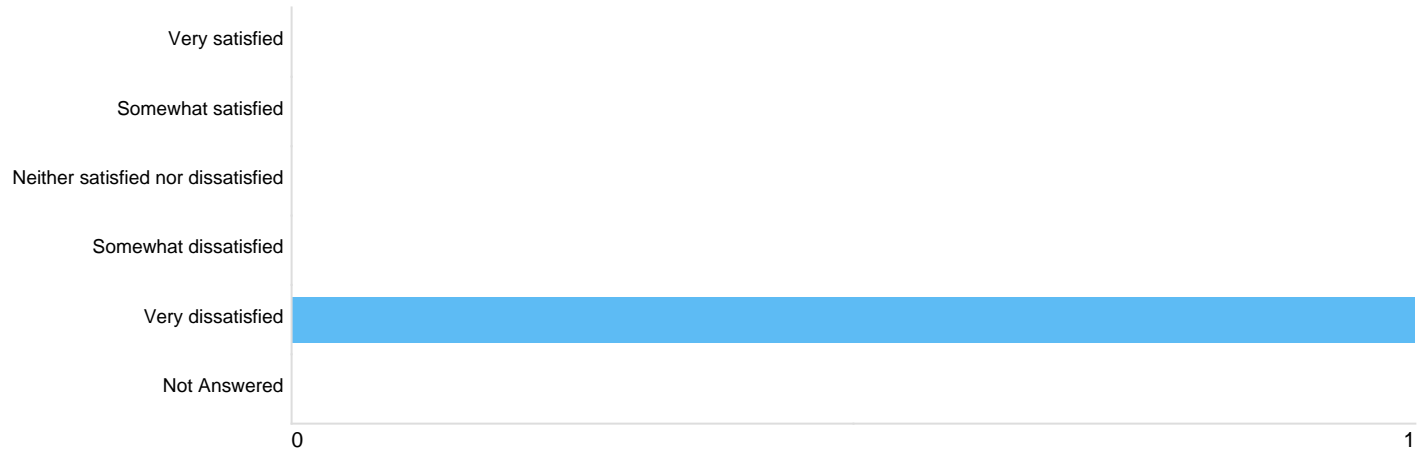
